


MESSAGE FROM THE SENIOR DIRECTOR

NEW IBC MINUTES REQUIREMENT



To promote transparency at federally funded research institutions, the National Institute of Health (NIH) now requires all Institutional Biosafety Committees (IBCs) to publicly post approved meeting minutes. Effective June 1, 2025, UF IBC minutes are now published at: https://ibc.research.ufl.edu/schedule.

Project titles must be included in the published minutes. To protect sensitive intellectual property, applicants are encouraged to avoid including proprietary information in project titles for new submissions or amendments. However, applicants must include adequate

technical details in their project submission forms for proper IBC review and approval, even if that information includes intellectual property.

While IBC members maintain strict confidentiality of all submissions, applicants may request redaction of sensitive information from the published minutes by contacting **bso@ehs.ufl.edu** at the time of submission. For additional information, read the **NIH Notice**.


FREQUENTLY ASKED QUESTIONS

EYE PROTECTION REQUIRED AT UF LABS

Personal Protective Equipment (PPE) is a vital safeguard for anyone working or visiting a laboratory. PPE is the last line of defense, providing a barrier between the user and potential hazards. Depending on the work being performed, required PPE may include lab coats, gloves, eye protection, face shields, or respiratory protection.

All personnel entering a lab at UF must wear eye protection. Eye injuries are one of the most common types of laboratory accidents, yet they are also among the most preventable. Even when active experiments are not underway, potential hazards remain present in the environment, making continuous use of eye protection essential.

CHEMICAL FUME HOODS

Chemical fume hoods are a key safety feature in laboratories. They protect staff by venting harmful vapors and fumes outside the building. To stay safe, always use fume hoods properly and report any issues right away. When the hood is not in use, keep the sash closed to ensure maximum protection.

EH&S profiles every fume hood once a year (or after any repair) to confirm it is working within safe limits. If your hood is tagged "Out of Service," do not use it until cleared by EH&S. For questions, contact EH&S Lab Safety at 352-392-1591 or labsafety@ehs.ufl.edu.

STATE VEHICLE POLICY REMINDER

WATCH OUT FOR BROWN WIDOW SPIDERS

Brown widow spiders are increasingly common at UF. They can be identified by their striped legs and orange hourglass markings, similar to the black widow. Their venom is more potent than the black widow's, but they inject less, so symptoms are usually limited to pain, nausea, and cramps.

Brown widow spiders often build nests with spiked egg sacs. If you spot brown widows on campus, contact EH&S Pest Control at 352-392-1591.
